The meeting was held in compliance with the General Circular issued by the Ministry of Corporate Affairs ("**MCA**") and Circular issued by the Securities and Exchange Board of India ("**SEBI**") and as per the applicable provisions of the Companies Act, 2013 and the Rules made thereunder.

The meeting commenced at 11:30 am (IST) and concluded at 12:20 pm (IST).

Mr. Rajeev Sikka, Executive Chairman of the Company chaired the meeting. The Chairman extended his warm welcome to all the shareholders and informed that 37<sup>th</sup> AGM is being held through Video Conference in accordance with the applicable regulations. The Chairman introduced the Directors, Key Managerial Personnel, Statutory Auditor and Scrutinizer of the meeting joined over VC. The requisite quorum, being present, the Chairman called the meeting to order.



Mr. Barun Pandey, the Company Secretary of the Company, read out the general instructions for the Members regarding participation in the Meeting and the e-voting procedure. He informed that as the AGM is being held through video conference, the facility for appointment of proxies by the members was not applicable and hence the proxy register for inspection is not applicable. He further informed that the Company had provided the Members the facility to cast their votes electronically through remote e-voting and Insta e-voting through e-voting system during the AGM. The remote e-voting commenced at 09.00 A.M. (IST) on Tuesday, September 26, 2023, and concluded at 05.00 P.M. (IST) on Thursday, September 28, 2023.

The Board of Directors had appointed Mrs. Gauri Balankhe Practising Company Secretary as the Scrutinizer to supervise the e-voting process.

Chairman further informed that there were no qualifications or observations or comments in the Independent Auditors' Report and in the Secretarial Audit Report. Therefore, it was not necessary to read the said reports at the Meeting.

With the consent of the Members present at the meeting, the Notice convening the AGM was taken as read. Since the meeting was being convened through VC, resolutions were put to vote through e-voting and the requirement to propose and second was not applicable.

Chairman announced that the details of the voting results (remote e-voting and e-voting at the AGM) on all the resolutions as set out in the Notice of AGM along with the Scrutinizer's Report shall be informed to Stock Exchanges and be placed on the website of the Company in due course.

In total 59 members were present at the 37th Annual General Meeting.
